BUSINESS / COMMERCIAL / NON-TYPICAL LETTER OF INTENT

To Install or Modify a Private On-site Wastewater System

This **Letter of Intent** requires a **\$600.00 fee** to be paid to the Northwest Local Environmental Protection Group (NWLEPG) office and this form shall be completed prior to construction or modification of the system. The fee may be paid by the owner or by the System Contractor as agreed by those parties. When a phone call is made to file this **Letter of Intent**, the form shall be sent **within 5 days** along with the required fee unless otherwise directed. When emergency situations occur and this form is filled out after construction of the system, this form shall be sent the first working day after construction along with the required fee. ***The NWLEPG must be contacted and arrangements made for inspection of the system's construction. This form & the fee is good for ONE year from the "Letter Date" listed below.*** Failure to complete the system in the ONE-year period will require the Owner / Contractor to re-file this form and the corresponding fee.

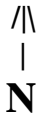
