Oil Field Water Supply Well Permit

This **Oil Field Water Supply Well Permit** requires a **\$200 fee** to be paid to the Northwest Local Environmental Protection Group (NWLEPG) office and this form shall be completed **prior** to construction of water well. The fee may be paid by either the operator licensed by the Kansas Corporation Commission (KCC) or the water well contractor licensed by the Kansas Department of Health and Environment (KDHE). **This permit and fee are valid for six (6) months from the permit date entered below.** As required by KDHE regulations in Article 30 (K.A.R. 28-30-7(e)), the KCC licensed operator is responsible for plugging this water well within 30 calendar days after termination of oil or gas drilling operations, or for conveying responsibility to the landowner in lieu of abandoning and plugging the water well. The transfer must be made through a legal document approved by KDHE and submitted to the Geology & Well Technology Unit at 1000 SW Jackson, Suite 420, Topeka, KS 66612-1367.
